



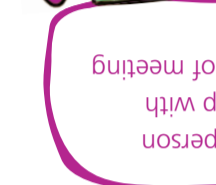
£300 could pay for a wheelchair for use in one of our Homes from Home, so children who are weak, tired, or disabled can spend time with their family while they're having treatment in hospital.



£100 could pay for a benefits advisor to help several families apply for state benefits. Cancer can have a huge effect on a family's finances, but the benefits application process can be lengthy and complex, putting an extra strain on the family's relationships and ability to cope at a very difficult time.



£15 could pay for some toys to create a fun, comfortable environment for children in one of our Homes from Home, which offer families free self-catering accommodation close to the main regional children's cancer centres. The atmosphere is relaxed and non-clinical, friendly and welcoming.



£8 could pay for a DVD to help prepare a young person with cancer to return to school. It helps them keep up with their studies and deal with the emotional challenges of meeting friends and teachers after their experience.
